Re: Searching on Auror

That's correct, system searches will only bring back a result if it is connected to an incident that a store has reported. However, it works a little differently for vehicles.

We have what we call Find a Vehicle (FaV), Track a Vehicle (TaV), and Automatic Video Retrieval (AVR). These features allow police members to find and track vehicles, and retrieve video footage from ANPR cameras linked to Auror. As such, a vehicle does not have to be linked to a store-reported event to be searchable on Auror.

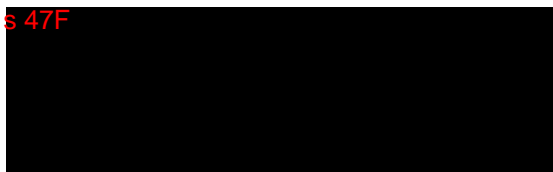
Using FaV, police members can surface any ANPR detections for a given vehicle in the past 60 days. Using TaV, police members can "track" a vehicle and receive instant, real-time ANPR detections for any given vehicle. Using AVR, police members can retrieve video footage from ANPR cameras without the need to attend in person. This process is automated and does not require the store user to send you the footage.

AFP/ACPT currently does not have access (except for ACPT State Intel) to these features as we are currently still in discussion with AFP regarding the use of Auror. If you have any thoughts on these features, please let

me know, and I'll pass them onto our § 47F




