<u>Notes</u>

- One complaint can contain multiple allegations.
- The 'Referred to NACC' column only displays database information extracted from a special category that has been marked indicating that the case has been referred to NACC and does not necessarily accurately account for all cases that may have been referred to NACC. In addition, this special category does not include an option for matters which have been referred back to the AFP for investigation by the NACC following initial referral.
- The NACC was established on 3 July 2023, and as such, matters prior to this date are not marked as having been referred to NACC.
- Established is the term used, following a code of conduct investigation into a complaint, to describe the finding that the alleged conduct complained of did occur and was a breach of the AFP Code of Conduct. The finding is made to the civil standard (on the balance of probabilities).
- Not Established is the term used, following a code of conduct investigation into a complaint, to describe the finding that the alleged conduct complained of did not occur and therefore there was no breach of the AFP Code of Conduct. The finding is made to the civil standard (on the balance of probabilities).
- **40TF (Discretion not to proceed)** under s.40TF of the Australian Federal Police Act 1979 (Cth), the Commissioner (or his delegate) may exercise their discretion to not take further action in relation to a complaint regarding a conduct or practises issue, if satisfied that one or more of the matters listed in s.40TF(2)(a)-(I) applies.

Under s.40TF(2)(a) – (I) as extracted from the AFP Act:

(a) the person became aware of the conduct, or the practice or procedure, more than 12 months before the person provided the information under section 40SA; or

(b) appropriate action has already been taken:

(i) against the AFP appointee in relation to the conduct; or (ii) in relation to the practice or procedure; or

(c) the person giving the information has exercised a right to have the conduct, or the practice or procedure, reviewed by a court or tribunal constituted by or under a law and there is no special reason to take further action in relation to the conduct or the practice or procedure; or













- (d) the person giving the information has a right to have the conduct, or the practice or procedure, reviewed by a court or tribunal constituted by or under a law but has not exercised that right and, having regard to all the circumstances, it would be reasonable for the person to have exercised that right; or SED BICE ACT 1982 SED BICE ACT 1982
- (e) the giving of the information is frivolous or vexatious; or
- (f) the information is trivial; or
- (g) the person giving the information did not give the information in good faith; or
- (h) the person giving the information does not have a sufficient interest in the AFP conduct issue or the AFP practices issue; or

(i) the conduct:

- (i) occurred when the AFP appointee was not or duty; or (ii) was private conduct of the AFP appointee: and was lawful and reasonable in the circumstances; or
- (j) the person giving the information is an AFP appointee, or has been an AFP appointee, and the information relates to action taken in relation to that AFP appointee as a result of information that was given and dealt with under this Part; or
- (k) the investigation, or further investigation, of the issue is not warranted having regard to all the circumstances; or

(I) any other condition specified in the regulations for the purposes of this paragraph is satisfied.
