Minister’s comments

Key issues

1. As forecast in MS24-000005, an Australian Federal Police (AFP) delegation, led by Commissioner Reece Kershaw APM, will travel to the People’s Republic of China (China) to

hold bilateral engagements with law enforcement counterparts between 17 and 21 March 2024. This will be the first time the Commissioner will have the opportunity to travel to China since commencement of his Commissionership in October 2019.

2. While in China, the Commissioner intends to meet with the Ministry of Public Security (MPS) to build upon existing information sharing arrangements and further strengthen our cooperation in the region. The Commissioner and delegation will take the opportunity to re-sign the *Statement of Intent on Combating Transnational Crime and Enhancing Police Cooperation*, the *Joint Agency Arrangement on Economic Crime Cooperation* and the *Taskforce Blaze Memorandum of Understanding* with the MPS.
3. The Commissioner and delegation will attend an official engagement celebrating the 25th Anniversary of the AFP's Beijing Post. Commissioner Kershaw's attendance at this commemoration will highlight the strength of the AFP's relationship with the MPS, and the success of our operational cooperation.
4. While in country, the Commissioner and delegation will also meet with the Australian Head of Mission, AFP members and their families at Post. He will also take the opportunity to lay a wreath at the Brice Steele Memorial. AFP Commander Brice Steele was Senior Liaison Officer in Beijing from 2001 to 2005, and was tragically killed in a plane crash in March 2007 in Indonesia at 35 years of age. In recognition of Commander Steele's strong relationship with the MPS, during his Australian visit in June 2007, former MPS Vice-Minister s 47F(1) and his delegation laid a wreath at the National Police memorial in Canberra in Commander Steele's honour.
5. The delegation will consist of four (4) travellers, Deputy Commissioner International and Specialist Capabilities, Lesa Gale APM, Assistant Commissioner Pacific Asia Command, Nigel Ryan APM, and Staff Officer to the Commissioner, Detective Superintendent s 47E(c) s 47E(c)
6. Representation at this level of seniority is equivalent to recent visits of MPS delegations to Australia. Deputy Commissioner Gale met with a senior delegation from MPS in April 2023 to renew the *Taskforce Blaze Memorandum of Understanding*. Established in 2015 and renewed annually, Taskforce Blaze is a joint AFP-MPS taskforce promoting law enforcement cooperation by successfully conducting investigations into organised criminal groups targeting Australia. Commissioner Kershaw and the delegation's upcoming travel will capitalise on the April 2023 engagement, ensuring continuity of cooperation and reiterating the significance of our police-to-police relationship with China at a senior level.
7. As Australia's primary international law enforcement agency, the AFP places great significance on its international partnerships to maintain and expand the AFP's offshore relationships and advocate for Australia's interests internationally.
8. While offshore, Deputy Commissioner Ian McCartney APM will perform the functions and duties of Commissioner. A Senate Estimates spillover hearing has been scheduled for 19 March 2024. Deputy Commissioner McCartney will attend and represent the Commissioner at this hearing. Under section 19 of the *Australia Federal Police Act 1979*, at any time when the Commissioner is absent from Australia, the next most senior member who is available, has and may exercise powers, and perform the functions and duties of the Commissioner.

The AFP recognises the importance of cooperation and coordination in law enforcement operations, particularly around transnational serious and organised crime threats common to both Australia and China.

17. Funding for travel is within budget for the Office of the Commissioner.

18. AFP Media is preparing a media strategy for this travel noting media attention is likely due to [redacted] s 33(a)(iii)


