### Average number of investigators employed in PRS

#### Notes

- In reporting this information a PRS investigator includes Professional members, Policing members (AFP Broadband 2-5) and Sergeants in the PRS Job Role of Investigator.
- Average Staffing Level (ASL) is the average number of full-time equivalent (FTE) employees receiving salary or wages for the financial year to date.

- The data shows PRS investigators average FTE according to budget. The data does not show how many were part time, job share, or on long term leave. This data can not be used to accurately demonstrate the number of 'active' investigators in PRS at any given time.
- ASL measures workforce expenditure against the budgeted ASL prescribed in the Portfolio Budget Statement (PBS) for the organisation for that financial year.
- The data is unable to be divided into work locations as the ASL is measures across PRS.
