### Shootings within the ACT

#### ***Wednesday 12 March 2025***

- At about 9.50pm on Wednesday 12 March 2025, police and emergency services received a report that a man had been shot in the leg.
- Police located the man near the intersection of Krefft Street and Eddy Crescent Florey, with significant lower leg injuries.
- He was taken to hospital by ACT Ambulance Service in a serious condition.
- Any witnesses to the shooting, or anyone with CCTV or dash-cam footage from the area is urged to come forward.
- This matter remains under investigation.

- At about 12.20pm on Friday 21 March 2025, police were called to assist ACT Ambulance Service paramedics in Florey who were responding to a man who had received minor wounds from shotgun pellets.
- After speaking to the man, police attended a residence in North Lyneham (where it is believed the incident occurred) and at about 1.40pm a 24-year-old man who was nearby was taken into custody in relation to the shooting.
- The 24-year-old man was charged with discharge a firearm – endanger life and assault occasioning actual bodily harm.

- s37(1)(a), s47E(d) was established on 30 March 2025 to investigate four shootings that occurred within the ACT between 25 and 29 March 2025.
- The 21 March 2025 shooting incidents in Lyneham and Florey are not thought to be linked to these four incidents.

- On Thursday 27 March 2025, a firearm was discharged inside a residence in Greenway with minor ricochet injuries to one occupant in the home.
- On Friday 28 March 2025, a firearm was discharged inside a home in Downer with a pet dog killed as a result of the shooting.
- On Saturday 29 March 2025, police and emergency services responded to a report that a man had been shot in the stomach at a residence on Knox Street, Watson.
  - Following an examination of the scene, police determined that the property was also shot at several times in a prior incident thought to have occurred on 25 March 2025.
- Police now believe a group of three men are responsible for these four incidents.
- The matters are currently under investigation.
